Barstool. Frame of steel tube, back of moulded plywood with CNCmilled cut-outs. Seat and back mounted with rivets. Mounted with interchangeable plastic glides.

The whole product incl. packaging materialRecycled content:39%Virgin content:61%

#### Life Cycle Assessment Data:

The Climate footprint = **36 kg of CO2e** in a level 2 screening validated by the Danish Company, Målbar. This result is based upon the lowest emitting variant of the model and is Målbar's estimate on the outcome within the boundaries of 28 - 42 kg of CO2e.

The CO2e accounts for carbon dioxide and other gases e.g., methane and nitrous oxide. The screening complies with the European LCA-rules PEF (Product Environmental Footprint) meaning that it covers the whole product life cycle incl. extrusion of raw materials to end-of-life handling.
