



## Peptide Plus 1.5 – Plain

*A ready-to-use, enzymatically hydrolyzed, peptide-based formula*

Hydrolyzed pea protein-based formula free of dairy, lactose, soy, gluten, corn, and peanuts. Each 325 mL carton provides 500 calories with prebiotic fiber, 24 micronutrients, and a blend of phytonutrients from 29 fruits, vegetables, herbs, and spices.

**AGE INDICATION:** 1 year and older

Do not heat. **For tube feeding:** Administer at room temperature. Follow healthcare provider instructions for clean handling techniques, flow rate, volume administration, and water flushes. May be used via pump, gravity or bolus as directed by healthcare provider.

**STORAGE:** Store unopened product at room temperature. Use by date printed on top of package. Once opened, replace cap, refrigerate and use within 24 hours.
