Design story of the product

Pato is a versatile chair concept based on a shell in 100% recycled polypropylene, which is also available with seat upholstery or fully upholstered, and with a wide range of bases. This version with a four-leg tube base is stackable and certified with the EU eco-label. Keeping material flows as clean and recyclable as possible, the Pato components are kept homogeneous to a degree where they can be recycled in the future as needed.
