# **EVOPANEL BY BORD PRODUCTS**7 YEAR LIMITED WARRANTY



## 1. Warranty Overview

Bord Products Pty Ltd ABN 22 169 711 086 ("Bord Products") guarantees that EVOPANEL by Bord Products panels purchased for residential or commercial interior use in Australia will be free from material and manufacturing defects for **seven (7) years** from the date of purchase. This warranty applies only to the original purchaser and requires proof of purchase for any claims.

## 2. Warranty Coverage

If an EVOPANEL by Bord Products panel is found to be defective due to manufacturing faults or material issues, Bord Products will, at its discretion:

- · Repair the panel,
- · Replace it with a comparable product, or
- · Refund the original purchase price.

#### 3. Exclusions & Limitations

This warranty does not cover damage caused by:

- · Incorrect installation, fabrication, or maintenance.
- · Accidents, abuse, misuse, or vandalism.
- Excessive heat, moisture, humidity, solvents, or harsh chemicals.
- Normal wear and tear, such as scratches, scuffs, or stains.
- Exposure to direct sunlight causing fading or discolouration.
- · Unapproved modifications or improper usage.
- · Poor workmanship during installation by third parties.

Additionally, this warranty does not cover:

- Minor imperfections or colour, pattern, and texture variations.
- · Use in outdoor environments.
- Factory seconds, discontinued stock, or 'as is' products.
- Products no longer part of the standard stock range at the time of a claim.

### 4. How to Make a Claim

To file a warranty claim:

- Notify Bord Products in writing within 7 days of discovering the defect.

If a product fails to meet acceptable quality standards and the defect is not major, you are entitled to have it repaired or replaced. If the failure is major, you are entitled to a replacement, refund, or compensation for any other foreseeable loss or damage.
