



## Fountain and Cascade Series Faucets Limited Lifetime Warranty

**Pelican Int'l warrants, to the original consumer purchaser only, parts and the finish used in Pelican Int'l faucets to be free from defects in material and workmanship, as long as the original purchaser owns the home in which the faucet is originally installed.**

**If the faucet is used in public space, for commercial, multifamily, industrial, or institutional purposes, or is installed outside of the Americas, Pelican Int'l warrants the faucet to be free from defects in material and workmanship for five (5) years from the date of purchase.**

Pelican Int'l houses all replacement parts for any minor defects and damages for new faucets purchased. Our in-house Faucet Specialist will work hard to give you the best customer service in handling your claim. If Pelican Int'l is not able to handle the defects or damages in a timely matter or we do not have the parts to handle your claim, we will then take the next step in issuing a new faucet.

To the greatest extent allowed by applicable law, Pelican Int'l shall not be liable or responsible for any special, indirect, incidental, or consequential damages arising out of or in connection with the use or performance of its faucets, even if Pelican Int'l has been advised, knows or should know of the possibility of such damages, and its liability under this warranty is limited to replacement of the defective material.

Except as set forth above, Pelican Int'l makes no additional warranties, implied or expressed, and any implied warranty including that of merchantability or fitness for a particular purpose, is limited in its duration to the duration of the written limited warranties set forth herein.

This warranty does not cover ceramic cartridges, parts or finishes which have been improperly installed, damaged, used in commercial applications, subjected to misuse or abuse, or are scratched or scuffed due to the use of corrosive or abrasive cleaning agents.

Shipping costs, labor costs, or any other costs associated with the installation or replacement of the product/parts are not covered under this warranty. This warranty is extended only to the original consumer/purchaser of the faucet and may be voided if the faucet is not installed by a trained professional.

This warranty gives you specific legal rights and may also have other rights, which vary from state to state, or province to province.

Any warranty of merchantability or fitness for a particular purpose shall be deemed to exist in connection with any of the goods or services supplied hereunder, and any implied warranties for a period greater than the warranty period contained in the Pelican Int'l limited lifetime warranty for faucets, are hereby excluded.
