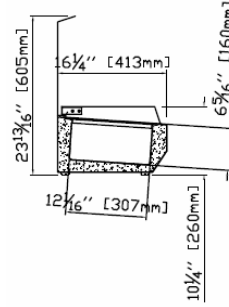
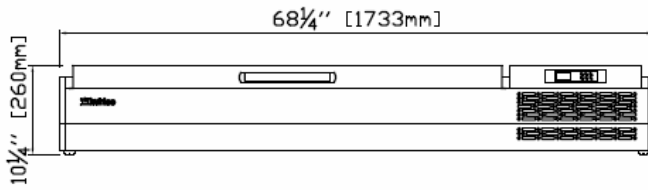

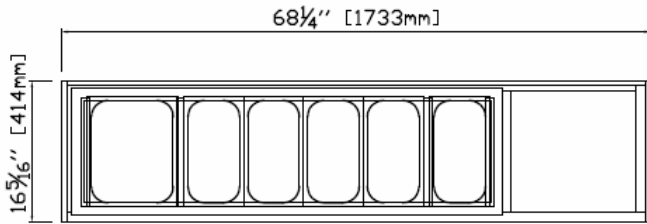
**PLAN VIEW**
