Compared to injection moulded plastic inserts, it is therefore considerably more wear-resistant and durable and will never chip even in sub-zero temperatures.

The break-proof steel tube handle is encased with an ergonomic non-slip rubber grip.

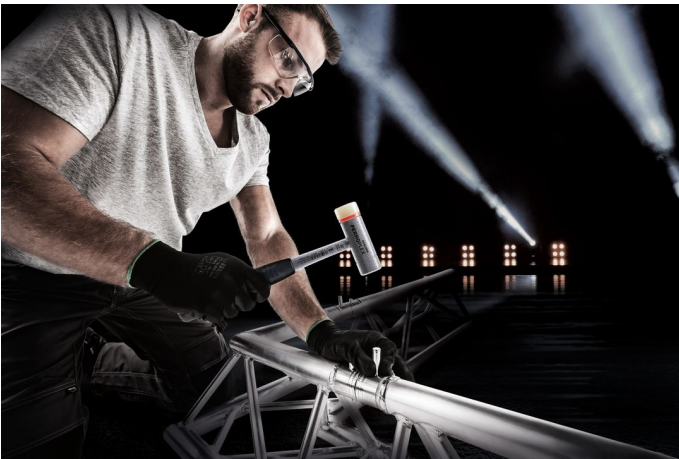
